For the first time in forty or so years, I find myself down to one gundog, my black Labrador, Jett. At eight plus years, he's retained the enthusiasm of a pup; in the field he gets down to business. He's better disciplined than the guy that shoots over him.

Between my son **Eric** and I, we maintained three (3) hunting dogs for most of these years, usually spacing them out five (5) years apart. One headed into retirement at 10 years, one in his prime, and always a youngster trying my patience.

It's funny, but when I was young, it seemed that I always had the time to take the dogs out and work them for 30 or 40 minutes most days. Back then, it seemed I had the time ... before I became more responsible and spent more time in the moment and less time thinking of the future.

It seemed that the dogs **Eric** trained were always superior in the field.

I started out with Springer Spaniels...Mo, Windy, and Clancy. Between the latter two was Rommel, the doggoned best field Cocker Spaniel ever. I used to get a few smirks when he jumped out of my Ford Falcon ...my hunting rig when I started. All were great fun to shoot ringnecks over. Clancy was a superior water dog... as good on ducks as upland birds. Windy trapped and retrieved more roosters in the sugar beets in the **Yakima Valley** than most people would believe.

I have to confess, every hunter has had a dog he doesn't talk much about. In the mid-70's, my friend **Randy Little** convinced me to try an **English Pointer**, we called her

In the latest **WWA** Newsletter, **Jim Cortines** wrote about the lack of ducks in the **Columbia Basin**, the reduction in numbers of duck hunters and related reduction in purchase of duck stamps. **Jim** said "Members, I'd like to hear your opinions on this subject. I'd like to publish some of your viewpoints in the upcoming newsletters."

Here is my feedback:

First, I've hunted the **Potholes** area since I moved to Washington state, which is since the early '90s. I, for one, agree with what **Jim** said regarding the number of ducks around the **Moses Lake** area specifically, especially the areas I hunt. I am a boot hunter. I've hunted around the **Winchester and Frenchman Hills Regulated Access Areas (RAAs)** since before **WDFW** made them "Quality Hunt Areas." I agree that there seems to be a change in how the ducks are using Basin. I just don't see the number of ducks like I used to. This year was especially poor in terms of number of birds seen. I don't have an explanation or any ideas where the birds are — other than the idea that warm weather keeps them up north longer than in the past. I read the **Refuge Forum** (<http://www.refugeforums.com/refuge/forums/washington-flyway-forum.36/>), and it seems like hunters around the Tri Cities were getting a lot of birds, even late this season. I've never hunted around the Tri Cities. I am a "west sider," and it is a bit too far for me.

Second, I'd like to add that it seems to be getting harder to find decent places to hunt where I am used to hunting. As mentioned above, I hunt near two **RAAs** - **Winchester and Frenchman Hills**. Honestly, in the past I spent the majority of my time at **Frenchman Hills**. Even though it is regulated, I never had issues getting access on most weekends when I hunted until recently. The past two (2) years have been something else. **Winchester** has always been hard to get into, the past two (2) years **Frenchman** has been nearly impossible to gain access. I talked to guys that are hunting it, they show up on Thursday night and camp out so they can get in line Saturday morning at 4:00 AM. For a guy that drives over Saturday morning, that is a bit hard to compete against.

So, back to the topic of the lack of ducks. I can't complain about people who have the time to beat me to the "head of the line" to get into an **RAA**. My solution to that is to find another place to hunt. I've spent plenty of time hiking around the two (2) areas mentioned. If you don't see ducks, you can't find another place to hunt!! I've typically hunted around the **Potholes** until freeze up, sometimes after if there are still ducks around. This year, even before freeze up, I shifted my hunting to the West side because I just did not see many birds. I have to admit, I really like hunting around **Moses Lake** and the **Potholes**. It obviously is so different than the West side. I just enjoy spending days in the desert and seeing the wildlife there, not just waterfowl.

I'm not going to stop hunting there — not yet anyway — and I'm certainly not going to stop duck hunting. I enjoy being outdoors too much and enjoy hunting with my dog too much (he is really enthusiastic about getting birds!). I don't know what the solution is yet. It does seem like in these times of high bird populations that hunting should be better, east and west of the mountains.

Last spring I was thinking about replacing Dusty. Something just didn't seem balanced with only having one dog after all these years. As fate would have it, member **Jim Wreggelsworth** advertised an exceptionally well-bred litter and OMG, he was only asking \$800 per pup.

I just couldn't pull the trigger and all the pups were spoken for in a heartbeat. I guess maybe, I didn't want to think about who'd take care of my pup after I was gone?

It's funny, every time I see a Little Nickel or the like, I invariably have to look at 'Labrador pups for sale'.

Recently, I saw some pups advertised that were, according to the ad, better bred than most human types. AFC, FC, CFC, MH, and I think a PHD on both sides. My God, at \$1700 per pup, I thought this litter should be working at Microsoft. And, that was with a "Limited Registration" meaning the new owner couldn't breed his pup when old enough without the approval of the breeder aaand/or kicking in more \$\$\$.

At first, I thought these folks had lost their damned minds. But then I recalled that my first 12 gauge I bought from **Sears Roebuck** back in 1968 cost about\$95, pretty much in line with what I'd paid for Mo. Maybe PHD pups are not so out of line after all, seems like these days it takes the better part of \$1400 for a modern shooter by the time you get it home. (Too bad **Jeff Bezos** don't sell 'em at Amazon)

Nonetheless, when it's all said and done, I know that whether it's \$500 or \$1500 for a pup; price wouldn't stop me should I decide to take the plunge one more time. The countless memories I've enjoyed throughout my life while watching my gun dogs do what they were bred for was truly an amazing experience.

I'm thankful for every one of them.

Avian Cholera Outbreak Deaths Climb to 4,200 Birds in ID

If you will recall in the February newsletter the appearance of Avian Cholera was brought to our attention with a die off of 3200 birds south of the Tri-Cities (see page 8 of the [February Newsletter](#)). Here is an update from **Roger Phillips, Idaho Public Information Specialist**.

Fish & Game crews and volunteers are picking up dead birds to minimize the impact.

Idaho Fish and Game personnel continue to find and collect dead waterfowl from an avian cholera outbreak in the **Parma** area, and officials now estimate

more than 4,200 birds have died since the outbreak started in early February.

The outbreak has occurred on private land, and the disease has killed mostly ducks, but also some geese and other birds. **Fish and Game** crews and volunteers are

collecting the dead birds and burying them at nearby **Fort Boise Wildlife Management Area** to prevent, or reduce, further spread of the disease.

"We're trying to minimize the impact," said **Tyler Archibald, Fish and Game** habitat biologist at **Fort Boise Wildlife Management Area**.

Avian cholera is the result of infection with the bacterium *Pasteurella multocida*. The bacterium kills swiftly – sometimes within 6 to 12 hours – and is released into the environment by dead or dying birds, or by birds carrying the disease.

Avian cholera is not considered a high-risk disease for humans, according to the **National Wildlife Health Center**. It is fairly common in Idaho, but this is a larger-than-usual outbreak.

"Outbreaks of avian cholera have occurred annually in the area over the past decade," **Archibald** said. Tight waterfowl concentrations can enhance disease.

transmission among healthy birds. **Archibald** said when more ponds, reservoirs and lakes thaw and waterfowl disperse, cholera outbreaks tend to diminish and eventually end.

If people see numerous dead birds, they are asked to call and report the location to **Fish and Game** within their region.

Willapa Bay Eelgrass Spraying Update:

I want to again thank all of you for commenting on the Wa Dept of Ecology (DOE) about the Willapa Bay eel grass spraying permit modifications.

We can make a difference! Without your support the spraying of Imazamox would have just continued as they had planned it.

I am not against the shellfish growers wanting to keep their beds clear, but it must be done in a way that the other areas are not affected by it. Both types of eel grass are too important for fish & wildlife. Japanese eel grass was introduced in years past but was not considered noxious until the shellfish growers wanted to spray it. In fact it was considered beneficial to fish and wildlife by the WDFW!

So the DOE issued a permit for spraying and it was studied for buffer zone data. The wrong amounts were used effectively changing the study. The buffer zones were bigger than expected with the use of the smaller amount. It has been brought to my attention that the amounts listed in fact sheets have changed periodically, and it's uncertain what amounts were used in the last study.

I will try and keep you all updated on the subject as information comes available. Thanks to WWA Life Member Ross Barkhurst for putting in his time on this project, and his concern and monitoring of the low wintering numbers of waterfowl on Willapa Bay.

Shillapoo Update - Ask Questions:

We've learned that work on the South **Shillapoo Project** is temporarily at a standstill due to the possibility of a lawsuit being brought by **Paul King** of the **CRANE** organization. **CRANE**, as the name implies, is primarily concerned with the welfare of Sandhill Cranes and these birds are one of the regulars using **South Shillapoo** during migration. Apparently, neither **CRANE** nor **WWA** believe that the proposed project will be beneficial to waterfowl.

While the project may be halted temporarily, it has not been cancelled, and we understand that all **WDFW/BPA** would have to do to keep the project alive after March, 2018, is to send someone out to turn one shovel-full of dirt prior to that date.

We urge all **WWA** members to email **Nicole M Czarnomski** (Nicole.Czarnomski@dfw.wa.gov) at **WDFW** expressing your concerns about this project.

While all letters of opposition are appreciated, it is best **the letter contain a question** so that **BPA/WDFW** can't simply respond with boilerplate. Here are some examples of possible questions you could ask and request response:

Appropriate questions might include:

- Was any **Pittman-Robertson** money used to develop water control or other structures at Shillapoo?
- What past grant money must be refunded due to the change of mission this project will bring to South Shillapoo?
- Have any studies of the effects on waterfowl of similar dike-breachings at **Willapa Bay** and other wildlife refuges been conducted and, if so, what were their conclusions?

- Have any studies addressed the possibility of the **South Shillapoo Project** lowering the water table at **North Shillapoo**?
- What studies have been initiated concerning the effects this proposed project will have on the federally Listed Columbian Whitetail Deer population at Shillapoo?


Chapter Work Parties


