

#### **Duck Nesting Maintenance**

During the last two (2) weeks of February, the **Seattle Chapter** checked and refurbished duck nesting sites in **Bellevue**, **Stillwater**, **Cherry Valley**, and **Issaquah**.


Chapter Artificial Nest Chair,

Bob Hazelbrook led a group of
Chapter members including Kelly
Salvage, Sean Williams, Trevor Morris,
and Todd Wisecarver at the Stillwater
Unit of the Snoqualmie Wildlife Area.
The group checked 27 boxes at this site,
cleaned them, and replenished the
nesting material. A total of 21 of the 27
boxes at the site appeared to be
successfully used.

Chris German helped us coordinate with a local Woodinville Boy Scout Troop. Bob Hazelbrook and James Ono met Chris and the rest of the Boy Scout volunteers at the Cherry Valley Unit of the Snoqualmie Wildlife Area.

The **Boy Scouts** and their parents were a great group to share this outdoor experience with. They asked great questions and were really excited to get out there and help with some "hands-on" conservation.

Unfortunately, due to the water levels at the site, we were only able to check six (6) boxes. One contained 8 unhatched eggs; another had a starling nest; but the remaining four (4) boxes appeared to have hosted successful Wood Duck hatches!

Thanks to directions from **WWA Member Brett Stark** who originally established artificial nesting structures within the city limit of Bellevue, **Frank Lyman, Frank Lee**, and **James Ono** met at the Mercer Slough Nature Park. One of the 2 Wood Duck Nest Boxes is broken beyond repair. The other was overgrown with branches and had been used by some sort of mammal.

We removed the leaves and mammal nest and added fresh nesting material.

The two (2) nesting tubes were in decent condition, but showed no signs of nesting. We refreshed the tubes with fresh hay. It has been a number of years since these nests had been checked so hopefully next year we will be able to see some utilization.

The final site we serviced was at the Emily Darst Park within the city limits of Issaquah.

John Arrabito led the work party and was joined by Frank Lee, Frank Lyman, Sean



Williams, James Ono, Trevor Morris, and Janelle Morris. One of the next boxes will need to be repaired, another appeared to have been nested in by a squirrel. We also added a new box. We refreshed 2 of the 3 nesting tubes and the 3<sup>rd</sup> appears to be gone. This site has also not been serviced in years and has struggled in the past. We will monitor for the next couple years and evaluate how viable the site is.

Since we found a number of boxes that need repair and the locations of some of the boxes need to be relocated, we will be doing a box build soon and organize more work parties for later in the summer.

Thank you to everyone who volunteered, we wouldn't have been able to do it without you.

#### Waterfowling 101

Waterfowling 101 will be an introduction to waterfowl hunting that we would like to initiate in the near future. We hope to create a multi-day seminar to help teach new hunters some of the basics of waterfowl hunting. In order to make this happen, we need a group effort to put together a curriculum. #### Recap of Virtual Chapter Meeting February 25th



# It's the Gunner, Not the Gun!

During the veterans' and military hunt last February 6<sup>th</sup>, pup **Skye** and I headed out for an area of the **Shillapoo Wildlife Management Area** just west of the City of Vancouver, WA for what we thought would be a terrific hunt. We had hunted this same location a year ago and were treated to flights of about 200 ducks and great numbers of geese, so our hopes were high.

In anticipation of close-range ducks over decoys I was armed with a CZ 28-gauge side-by-side whose stock I've sanded to fit, since I'm a left-handed shooter. I choose this gun because it's the one I now shoot most accurately. For the geese, I intended toting a 13-pound old Ithaca Mag-10, a real cannon. I had #5 copper plated Boss bismuth cartridges for the 28 and #10, T-sized steel shot for the cannon.

Since the location I choose was a long hike from any road but near a small river, I hauled a bunch of dekes out the day before with my boat. At "0 Dark Hundred Hours" on the 6th, **Skye** and I hiked the couple of miles from the road and, with great expectations, began setting the dekes out. Once legal shooting time neared, I loaded the 28 then discovered to my chagrin that the other gun bag I'd toted contained my old **12-gauge Parker** instead of the **Mag-10**. Since neither 10 nor 28-gauge shells do well in a **12-gauge Parker**, my only weapon was the 28-gauge peashooter! Oh well, the pup and I settled in for some close shots.

At first legal light the peashooter terminated the flight of an incoming duck which, of course, turned out to be a pintail hen. After that, in great contrast to the previous year, we went an hour and a half without seeing another bird even at great distance. What a disappointment!

Throwing in the towel at about 10:00 am, I unloaded the little CZ and started the long trek back to our truck, after which I'd have to bring the boat and retrieve the dekes. As we approached the truck, we heard a noise like a football crowd and, as we turned the last corner of our trail, came across a sight to behold. There in a large cornfield were thousands of snow geese! There were so many the field did indeed look like it was covered with snow! Some birds were always in the air, wheeling around and rejoining the flock.

Feverishly dumping the rest of the gear, I reloaded the 28, hoping for a close-up jump-shot. On my knees, the pup and I inched through the mostly knocked down cornstalks to within about 40 yards of the flock but then had to stop as the nearest birds were all looking our way with necks up. Waiting with bated breath (yes, that's the correct spelling, lol) for the flock to inch closer or for some wheeling birds to fly over us proved fruitless.

After about a half hour of cramped and freezing legs, I decided to take one shot as soon as one of the birds came within about 40 yards of us. When one finally did, I

focused on its head and fired the peashooter. To my total amazement, the bird folded and hit the ground with a thud! As Skye was making the easy retrieve, I stared at my little CZ in wonder. Did my 28 really do that?!

Upon inspection, it turned out that the center of my shot-string had perfectly nailed the bird's head, one bb even penetrating its brain. A pretty lucky shot as I struggle with a shotgun, but **Skye** and I will take it!

Of course, the moral of this story is that a well-placed shot is much more important than gauge, shot size, and shot density. If the shooter misses the bird, none of that stuff much matters!

Of course #2, I forgot to take pictures of the truly amazing snows, so you'll have to imagine the sight with this stock photo.

Waterfowlers needs a community that is willing to go the extra mile. Breaking down barriers and providing opportunity is how the **WWA** made me a waterfowl hunter.

I look forward to starting next year's season with a little more grit, a greater appreciation for wild birds, and confidence in my abilities. Thanks **Washington Waterfowl**Association!



#### The "Union River Blind Project" Update

We have at this time \$1,425 donated and pledged for the project! Once again, I am in awe at the generosity of the waterfowlers! You always come through for the conservation of waterfowl and for fellow waterfowlers! I recently sent out an update to the team, and soon I will be sending out the same update to those that volunteered to help out and to the many donors.

One point I would like to make about it here is that there is only \$350 of ALEA (Aquatic Lands Enhancement **Account)** grant money available to this project — barely enough to replace or repair the anchor chains for the two (2) floating blinds. SO, I have split the Project into three (3) phases. Phase 1 will be funded by the current beg-a-thon that I'm doing. Phase 2 hopefully will be funded by a future grant from the state Duck Stamp Fund OR another ALEA grant!

Many thanks to all the WWA individual members and WWA Chapters that have donated! We could not get these projects done without you all.

# **NW Chapter News**

#### **March Chapter Meeting**

Our guest speaker at the March chapter meeting was Rob Wingard — WDFW Private Lands Manager and Biologist for Region 4.



**Rob** provided the attendees with information on the **Private** Lands hunting Program.

https://privatelands.wdfw.wa.gov/private\_lands/.

This is a state wide program that provides the public with opportunities to hunt at private properties. Land owners in partnership with **WDFW** allow public hunting on their properties. The process includes lands designated as:

- Feel Free to Hunt,
- Register to Hunt,
- · Hunt by reservation, and
- · Hunt by Written Permission.

**Rob** shared information on sites within **Snohomish**, **Skagit** and **Whatcom** counties, including some of the new sites introduced in the 2020 season and an overall increase in register to hunt site utilization. Feedback on some of the sites was provided by chapter members.

**Rob** gave us a forward look at some of the planned enhancements to the program and how the program is currently financed through the *Farm Bill* for site access contracts with land owners and **Duck Stamp** funding for foraging crops planted. Foraging crops by acreage planted

for the 2020 season on the west side include 40 acres in the **Bayview/Edison** area; 30 acres in **Snohomish County;** and 30 acres in **Whatcom County.**

# **Moses Lake Chapter News**

I have completed an **ALEA** (**Aquatic Lands Enhancement Account**) grant request for \$33,000 for a habitat improvement project at the **Royal Lake** complex. This project will tag along with a Stamp & Print money request by **WDFW** for the removal of Russian olive trees on the site. The project will be funded in the 2021-2023 funding cycle.

Once that is done the **ALEA** grant will be used to purchase spray and tillage work to eliminate non-native vegetation in the area and replant native grasses and forbs.

This will be followed by the planting of 3,000 native shrubs to provide nesting cover and winter food.

- I will not be held responsible for a bird that is lost to rot, extensive damage, heavy amounts of pinfeathers, dog bite or slobber damage, freezer burn nor any other damage caused by improper storage by the hunter prior to my receipt of the bird.

# **WA Legislative Report**

Editor's Note: This article is written entirely by the Hunters Heritage Council (HHC), a Washington State based organization dedicated to political action on behalf of the hunting and related communities of Washington. The Washington Waterfowl Association (WWA) had no input into this article. This article is in this newsletter because of WWA's membership in Washingtonians for Wildlife Conservation (WWC). WWC is a member organization of HHC. The opinions contained in this article are entirely those of the author, and the Hunters Heritage Council (HHC).

Last Minute News Flash: From our lobbyist Tom Echols - HB 1375 – the crazy animal-rights bill that uses COVID as an excuse to ban mink farms, ban fur farms, and ban the production of fur – is DEAD for 2021. Unfortunately it will be pushed hard in 2022 under a different bill number. It pays to have a great lobbyist in Olympia. Thank you for your efforts, Tom!

We have come to the halfway point in session and we have passed three (3) major cut-offs, February 15 House of Origin Policy Committee cut-off; February 22 House of Origin Fiscal Committee cut-off; and March 9 House of Origin floor cut-off. This means that all bills that were introduced have to be passed out of the chamber they were introduced in by March 9 or they are considered dead. The only exemptions are budget related items.

As I mentioned in the last month's WWA

Newsletter, I feel that SB 5159, the PILT (Payment In Lieu of Taxes) bill, is the most important bill to hunters this legislative session. I thought that there may have been some hard sailing for the bill since Senate Ways and Means Chair Senator Christine Rolfes of Kitsap County was not a fan of the PILT bill, but SB 5159 passed the state senate on third reading 47 - 2, with Senator Rolfes being one of the two (2) dissenting votes. It is now sitting in the House Committee on Rural Development, Agriculture & Natural Resources, where it is scheduled for a March 17th hearing. Passage of this bill would keep WDFW from being at war with rural counties when they buy land for rec purposes.

#### **Hunting Bills Shut Out**

Neither one of the two excellent hunting bills ever

got a hearing, and both died. **HB 1185** which would have given discounted hunting licenses to seniors 70+ died with the February 22 House of Origin Fiscal Committee cut-off, and **SB 5187**, which exempts a non-profit gun club from paying sales tax on clay targets on activities that they are charging a fee, died for the same reason.

Another bill that died with the March 9 House of Origin floor cut-off is **HB 1261** — a really interesting bill because of its background. **HB 1261** would have doubled the non-reporting penalty for hunters from \$10 to \$20, but this was **NOT** a piece of agency request legislation. Someone in a sportsman's club requested their legislator sponsor this and **Representative Brad Klippert** of **Kennewick** is great friend of the **HHC** and of the overall hunting community, is an outstand legislator. This legislation puts everyone in a bad spot, because if you oppose it, you oppose increased reporting, yet hunters that don't report, still won't report, so you're not going to increase reporting by that much.

One bill that passed with overwhelming support is SB 5146, which authorizes the WDFW Commission to indemnify the United States and its agencies as a condition of securing federal funds for purposes of fish, shellfish, and wildlife projects. Certain federal agencies may require indemnification language in their contracts. For example, the United States Army Corps of Engineers requires indemnification for damages arising from the design, construction, and operation of aquatic ecosystem restoration projects. This bill passed the state senate unanimously on February 23rd by a 49 - 0 vote!

Since HB 1375 ultimately died (See News Flash Box above), I'll spare you the majority of my anger about how the bill still got a hearing on March 10th in the House equivalent of the Natural Resources Committee — AFTER the three cut-off dates have already passed! The House Democrats — the party in power, who sets the cut-off dates — didn't even play by the rules that they set for the Legislature to be run by.

It is a travesty that this bill was even heard! This bill was such a poorly written, garbage of a bill, and to pander to the animal-rights (AR) community like that is sickening. The AR people from around the world came to submit comments. The bill did contain an exemption for taxidermy, but this bill, while it doesn't affect hunting, we have to support our allies in the trapping and ranching communities. This bill should never have received a hearing! But Rejoice — It's **DEAD** for now!

# **Keep the Pressure on Re: Your Preference for Appointments to the WDFW Commission**



Washington Outdoorsmen and women are still waiting for the **Governor Inslee's** final appointment to the **Fish and Wildlife Commission**, so there is still time to voice your preference for **Rylan Weythman**, via the online portal listed at the end of this post introducing him.

Support one of our own. Support someone who has sat in the same blinds, glassed the same clear cuts, fished the same holes, and, more importantly, who shares the same core values as the Washington Hunting and Fishing Community.

It also wouldn't hurt to mention that Governor Inslee's two most recent appointments to the **WDFW Commission**, were specifically in violation of state law; more specifically in violation of RCW 77.04.040 linked here.

RCW 77.04.040 was put in place to keep balance on the **Commission**, so all Washingtonians have a fair shot at enjoying the outdoors. The Commission is the <u>Citizens</u>' representation on wildlife management.

Please help restore "fair citizen" representation on the WDFW Commission. Support Rylan Weythman!

**Rylan** is an avid hunter and fisher, and not just waterfowl but also big game, turkey, and upland birds. His personal background gives him unique personal knowledge of both sides of the Cascades. He and his wife **Sara**, a school teacher, currently live in Okanogan County, after spending the better part of the last 10 years in King County.

He was raised and schooled near **Wenatchee** -- specifically **Cashmere** – where he spent most of his summers (and more) fishing for salmon on the nearby **Columbia River.** He left **Cashmere** to go to college and law school in California. In 2012 he returned to Washington and is currently a Partner at the prominent law firm of **Foster Garvey**, where he is a litigation attorney.

Rylan is a very attractive Commission candidate because in one sole appointment he is the perfect replacement for Dave Graybill, who was from Wenatchee, and Rylan would maintain representation of that part of the state on the Commission. 





# **Food For Thought**

Up Your "Game" with an Easy Pan Sauce for Duck Breast

So you just seared a duck breast to a perfect medium rare. It's now on the cutting board resting and you think how can I up my "game." How about making a pan sauce? This is a simple way to change up the flavors to your dish and compliment the tasty duck.

- Once your breast is seared remove the excess oil from the pan.

- Add a tablespoon of good mustard (stone ground or brown. NOT yellow).



- Goose and duck nest counts and banding of both with the WDFW and USFWS
- Working with the WDFW on dove counts & planting WDFW food plots in Eastern WA with WWA owned tractor and farming implements
- Sponsoring of the Annual NW Decoy Collector's Show
- Participating in multiple Sportsman's shows annually
- Donation of funds and volunteer man hours for Swan Mortality Mitigation Studies
- Donation of funds and man hours to WDFW for goose banding and satellite tracking
- Litter pickup projects at public hunting areas, boat ramps, and along highways; and conducting multiple fund raising banquets annually to pay for all of these "hands on" conservation projects.
